PUBLIC HEARING

Rezone Parcel 54B-01-234

Chairman Brown said there is a public hearing tonight to receive input regarding a change of zoning classification from B-1, General Commercial to R-1, Single Family Residential for the construction of a single family home. He asked Mr. Stallings to give an overview.

Mr. Stallings explained that the applicant wishes to rezone parcel 54B-01-234 from its current B-1 zoning to R-1 to allow for the construction of a single family home. He said this parcel is located at the corner of South Court Street and East Griffin Street. He said the applicant is in the process of combining several adjacent parcels into one single lot. Mr. Stallings said this rezoning would allow the applicant to proceed with cleaning up several smaller lots in order to make one home site.

Chairman Brown opened the public hearing. With there being no one to speak either in favor or in opposition of the proposal, he closed the public hearing. He then opened the matter for discussion among the Planning Commission.

Commissioner Willis made a motion to forward the request to rezone parcel 54B-01-234 from B-1, General Commercial to R-1, Single Family Residential to Town Council for approval at their June 12, 2018 meeting. Commissioner Stubbs seconded the motion, and the Commission unanimously passed the motion as recorded on the attached chart as motion #2.
