Monthly Summary Report for November 2014

On 11/5/14 at 1610 hours 1st Sgt. Riddle observed a wanted subject in the 5 block of Joyner Ave. 1st Sgt. Riddle and Officer Gutierrez made contact with the suspect and took him into custody for a Contempt of Court warrant. Search incident to arrest the suspect was found to be in possession of Marijuana. Suspect was charged with Possession with Intent to Deliver Marijuana. Contraband was seized.

On 11/7/14 at 2310 hours MPO Owens responded to the 100 block of Martlette St. for a disturbance. Upon arrival it was determined that one of the involved parties was wanted for on an outstanding warrant for Assault and Battery. Suspect was arrested without incident.

On 11/8/14 at 1830 hours Officer Gutierrez responded to the 11500 block of Windsor Blvd. for a domestic disturbance. Upon arrival Officer Gutierrez was assisting a party in gathering personal property to leave when the suspect spit on Officer Gutierrez. Officer Gutierrez attempted to take the suspect into custody and the suspect began striking Officer Gutierrez. After a brief struggle the suspect was arrested and charged with Assault and Battery on a Law Enforcement Officer.

On 11/14/14 at 1730 hours Officer Gutierrez was responding to a Trespassing call when he observed the suspect fleeing the scene in a vehicle operating recklessly. Officer Gutierrez stopped the vehicle in the 12300 block of Windsor Blvd. It was determined that suspect was wanted on a Contempt of Court warrant. Suspect was also determined to be intoxicated and charged with DUI, Underage Possession of Alcohol, Reckless Driving and Trespassing. Suspect was arrested without incident.

On 11/15/14 Officers Swan and Harris completed an investigation into a shoplifting offense at 57 W. Windsor Blvd. Officer Harris identified the suspect through security video and obtained a warrant for Concealment of Merchandise. Officer Swan located and arrested the suspect without incident at her residence.

On 11/16/14 at 1800 hours Officer Harris responded to a single vehicle accident in the 10 block of Bank St. Upon investigating the accident it was determined that driver was under the influence of alcohol. Suspect was arrested for DUI without incident.

On 11/16/14 at 0230 hours Officer Swan attempted to stop a vehicle for speeding and a possible DUI offense. Suspect vehicle refused to stop and fled from Officer Swan. Officer Swan pursued the vehicle into Suffolk. The vehicle lost control and wrecked in a cotton field





and the driver fled on foot. Officer Swan with assistance from Suffolk PD was able locate the suspect inside a residence in Suffolk. The suspect attempted to flee on foot again and was apprehended by an SPD K-9 unit. Suspect had 2 outstanding felony probation violation warrants on file in Suffolk for PWID Cocaine and Malicious Wounding. Suspect was charged with DUI 2nd Offense, Felony Eluding Police, Reckless Driving and Driving on a Suspended License.

On 11/17/14 Officer Swan stopped a vehicle in the 10 block of W. Windsor Blvd. for a traffic offense and possible DUI. Suspect failed all sobriety tests and was arrested for DUI. Suspect refused to take a breath test and was also charged with Refusal.

On 11/23/14 at 1400 hours Officer Swan and Sgt. Jernigan stopped a vehicle in the 50 block of E. Windsor Blvd. for a traffic offense. It was determined that driver was wanted out of Suffolk on a warrant for Failure to Appear. Suspect was issued several traffic summonses and arrested without incident.

On 11/23/14 at 1615 hours Officer Swan stopped a vehicle in the 70 block of E. Windsor Blvd. for a traffic offense. Upon making contact with the driver Officer Swan smelled a strong odor of burnt Marijuana. Suspect was issued several traffic summonses and a criminal summons for Simple Possession of Marijuana. Contraband was seized.

On 11/26/14 at 1330 hours Officer Harris stopped a vehicle in the 11200 block of Windsor Blvd. for a traffic offense. Upon making contact with the driver it was determined that he was wanted out of Portsmouth on a warrant for Failure to Pay Child Support. Suspect was taken into custody without incident.

On 11/28/14 Sgt. Jernigan was contacted by a victim in regards to forged and stolen checks. Sgt. Jernigan met with the victim and it was determined between January 2014 and October 2014 that the suspect had forged and uttered 40 checks on the victims account at Farmers Bank in Windsor. Victim had lost over \$3000.00 in funds from her account. Sgt. Jernigan along with investigators from Suffolk PD and the Southampton Co. Sheriff's Office identified the suspect. Other forgeries and utterings were discovered in those jurisdictions as a result of the investigation. Sgt. Jernigan obtained warrants for Grand Larceny, Forgery, Uttering and Identity Theft. Investigators in the other jurisdictions also obtained warrants. The suspect remains at large and the investigation is ongoing.
