Subject: Monthly Summary Report for June 2014

On 6/1/14 at approximately 0045 hours Officer Swan responded to the 9000 block of W. Windsor Blvd. for a single vehicle crash. The investigation determined the driver was operating the vehicle under the influence of prescription narcotics. Suspect was arrested without incident and charged with D.U.I.D.

On 6/7/14 Sergeant Jernigan responded to 65 Church St. for a report of a domestic dispute. The investigation revealed that the wife assaulted the estranged husband there were visible injuries. Suspect was arrested without incident and charged with Assault on a Family Member.

On 6/10/14 at approximately 1410 hours 1st Sgt. Riddle responded to the 12000 block of Windsor Blvd. for a 4 vehicle crash with an entrapment. One driver was extricated from a vehicle and succumbed to her injuries while en-route to the WVFD to be airlifted to the hospital. No other injuries were reported. Virginia State Police were contacted to lead the investigation because of the need for complex accident reconstruction. The deceased driver was determined to have been at fault.

On 6/14/14 at 0802 hours 1st Sgt. Riddle and Auxiliary Officer Gutierrez responded to 34 Duke St. for a report of a deceased male. 91 year old victim was found deceased in the residence. Investigation determined the victim died of natural causes. Parr Funeral Home was contacted to remove the victim from the residence.

On 6/14/14 at 0945 hours 1st Sgt. Riddle and Auxiliary Officer Gutierrez observed a juvenile wanted on an outstanding Detention Order for Burglary at the intersection of Court St. and Windsor Blvd. Juvenile suspect was taken into custody without incident and transported to Chesapeake Juvenile Services.

On 6/15/14 Officer Harris responded to accident with injuries that occurred on the property at Fox Run Farms. Victim was operating a four wheeler and was ejected from the ATV. Victim suffered serious injuries and was airlifted to Norfolk General. Investigation is ongoing and alcohol appears to be a factor. A document search warrant was issued for medical records in relation to this ongoing investigation.

On 6/18/14 at approximately 1720 hours Officer Swan and 1st Sgt. Riddle responded to the 23300 block of Courthouse Hwy for a disorderly subject. Upon arrival officers located an elderly male in the roadway swinging a fence board at employees of Consulate Healthcare. Officers were able to take the suspect into custody without incident. Investigation determined that the suspect was a patient in the Alzheimer's unit who had escaped by climbing a fence after assaulting a staff member. Suspect suffered minor injuries during the escape and was treated on scene by MEDIC. Suspect was held on an Emergency Custody Order and evaluated by mental health workers. Suspect was placed into the custody of Eastern State Hospital for treatment.

On 6/22/14 at 1715 hours Sgt. Jernigan located a wanted subject in the 11100 block of Beale Dr. Suspect was taken into custody on two outstanding Misdemeanor warrants without incident and transported to Western Tidewater Regional Jail.

On 6/23/14 at 1720 hours 1st Sgt. Riddle and Officer Swan responded to 60 W. Windsor Blvd. for a Simple Assault. Report was taken and warrants were advised. Victim obtained a Misdemeanor Warrant for Assault and an Emergency Protective Order. Officer Harris located and arrested the suspect without incident.

On 6/25/14 at 2145 hours MPO Owens was dispatched to 23183 Bass St. for welfare check. MPO Owens investigation discovered that victim had not been seen or been in contact with anyone for 10 days and had previously expressed suicidal ideations to a neighbor. 1Sgt. Riddle and Sgt. Jernigan responded to the scene. Entry was made to the residence and the 62 year old male victim was found to be deceased. Investigators determined cause of death to be a self-inflicted gunshot wound to the head. Scene was processed and the decedent was transported to the Medical Examiner's Office. An initial finding by the Medical Examiner's Office is a Suicide. Investigation is ongoing.

On 6/27/14 at 1510 hours 1st Sgt. Riddle responded to 1 E. Windsor Blvd. for a domestic assault call. Victim stated she had been assaulted by her boyfriend at 60 E. Windsor Blvd. Victim suffered minor injuries and declined MEDIC. Suspect was located and taken into custody without incident for Assault on a Family Member. Emergency Protective Order was obtained and served on both parties.
