Monthly Summary Report for October 2014

On 10/2/14 Sgt. Jernigan and MPO Owens stopped a vehicle for an equipment violation at Courthouse Hwy. and Belmont St. The driver of the vehicle was determined to have outstanding warrants for his arrest for Contempt of Court and Revocation of a Suspended Sentence. Driver was arrested without incident and issued several traffic summonses.

On 10/3/14 Officer Harris observed a suspect trespassing on the property at 19 W. Windsor Byld. Suspect was arrested for Trespassing without incident.

On 10/5/14 Officer Harris responded to the 30 block of Church St. for a report of child neglect. Officer Harris recovered a small child playing alone near the street without any supervision. Parents were located and both charged with Contributing to the Delinquency of a Minor. Child Protective Services was notified and responded.

On 10/6/14 Officer Swan conducted a traffic stop in the 12000 block of Windsor Blvd. Upon making contact with the suspect he smelled a strong odor of marijuana coming from the vehicle. Suspect was arrested for Possession of Marijuana and issued several traffic summonses. Contraband was seized.

On 10/7/14 Sgt. Jernigan responded to the Dollar General at 57 W. Windsor Blvd. for a report of shoplifting. Upon arrival Sgt. Jernigan located the suspect who attempted to steal a bottle of pills. Suspect was arrested for Petty Larceny without incident.

On 10/12/14 Officer Gutierrez responded to the 140 block of Hidden Acres Circle for a report of a Domestic Assault. Upon arrival the victim claimed to have been assaulted by her brother. Suspect was taken into custody for Assault and Battery of a Family Member. Protective order was issued and served.

On 10/14/14 Officer Swan responded to Clydesdale Trailer Park in regards to a report of a rape. Victim claimed to have been raped earlier in Windsor Manor Park by the suspect. Victim was intoxicated and initially uncooperative. The next morning Sgt. Jernigan and Officer Swan interviewed the victim who agreed to cooperate. Search warrants were obtained for the suspect's residence and executed. DNA evidence was recovered. Suspect was arrested and interviewed. Upon further investigation and an additional interview with the victim charges were nolle prossed and the complaint withdrawn.

On 10/15/14 Officer Harris met witch a victim at the Police Department. Victim claimed to have been sexually assaulted in the 12000 block of Joynertown Ln. Suspect was identified and warrants were secured for Aggravated Sexual Battery. Suspect was located by Sgt. Jernigan and arrested without incident.

On 10/16/14 MPO Owens was investigating a reckless driving compliant when he made contact with the suspects at 60 W. Windsor Blvd. Both suspects were highly intoxicated and placed under arrest for Public Intoxication. Search incident to arrest MPO Owens recovered 28 tablets of Xanax from the female suspect. Additional warrant was secured for PWID Schedule IV Controlled Substance. Contraband was seized.

On 10/19/14 Officer Swan responded to a vehicle accident in the 13000 block of Windsor Blvd. Driver of the vehicle was determined to be under the influence of an alcoholic beverage and arrested without incident for DUI.

On 10/20/14 Officer Swan observed a suspicious person in the parking lot of 60 W. Windsor Blvd. Upon making contact Officer Swan recovered marijuana from the suspects' person. Suspect was arrested for Possession of Marijuana.

On 10/28/14 Officer Swan stopped a vehicle for driving recklessly at 1 E. Windsor Blvd. Upon making contact with the driver it was determined he was under the influence of alcohol. Suspect was arrested for DUI and Refusal of a Breath Test without incident.

On 10/29/14 Officer Swan responded to Consulate Healthcare for a report of an assault. Upon arrival the Nursing manager and several witnesses reported that a staff member had assaulted a patient. Victim suffered minor injuries. Suspect left the scene prior to officers arriving. Suspect refused to meet with investigators to give a statement. Warrants were obtained for Abduction, Assault and Battery and Neglect of an Incapacitated Adult. Suspect was arrested in Virginia Beach without incident.
