Subject: Monthly Summary Report for January, 2015

- On 1/6/2015 Officer Swan made contact with a suspicious person at the intersection of Court St. and A Street. Suspect admitted to possessing drug paraphernalia and was arrested without incident. Contraband was seized.
- On 1/6/2015 Officer Swan was out with a suspicious person when a relative pulled up to check on the subject. The relative exited the vehicle and had a strong odor of an alcoholic beverage about her person. Suspect failed all field sobriety tests and was subsequently arrested for Driving under the Influence.
- On 1/9/2015 Officer Owens stopped a vehicle in the 60 block of W. Windsor Blvd for a traffic violation. Upon making contact with the violator Officer Owens noticed a strong odor of alcohol. Suspect failed all field sobriety tests and was arrested without incident for Driving under the Influence.
- On 1/12/2015 Officer Swan stopped a vehicle in the 23200 block of Court St, for a traffic violation. Upon making contact with driver Officer Swan detected a strong odor of marijuana coming from the vehicle. During a search marijuana and smoking devices were recovered. Suspect was arrested for Possession of Marijuana and Possession of Drug Paraphernalia. Contraband was seized.
- On 1/19/2015 Officer Swan stopped a vehicle in the 12100 block of Windsor Blvd. for a traffic violation. Upon making contact with the driver Officer Swan noticed an odor of marijuana coming from the vehicle. During the search a loaded concealed handgun was found under the driver's seat. Suspect was charged with carrying a Concealed Weapon. Firearm was seized.
- On 1/24/2015 Officer Harris made contact at 1 E. Windsor Blvd. with a subject during a call for an alcohol violation. A VCIN check showed the suspect was wanted for an outstanding felony warrant for Revocation of a Suspended Sentence. Officer Harris took the suspect into custody without incident.





- On 1/27/15 Officer Swan observed a suspicious occupied vehicle in the parking lot of Windsor Court Apartments. Upon making contact with the driver it was determined she had an outstanding warrant for Failure to Appear from Chesapeake. Suspect was arrested without incident.
- On 1/31/2015 Officer Owens stopped a vehicle in 30 block of W. Windsor Blvd. for speeding.
 Upon making contact with the driver Officer Owens noticed an odor of marijuana coming from the vehicle. Officer Owens recovered marijuana from the suspect who was charged with Possession of Marijuana. Contraband was seized.
