Subject: January 2015 Planning and Zoning Report

Zoning Permits: In January there were ten Zoning Permits. This is substantially more than the three in December but slightly less than the twelve in January 2014. The permits were for a new residence, four permanent signs, a fence, two decks and also two new businesses which located in existing vacant offices. All in all it was a very positive month.

Violations: There were also ten new violation cases in January (substantially more than the three in December and also much more than the six cases in January 2014). The violations were for nine inoperative motor vehicles and a junk/debris case. More importantly, seven violation cases were resolved, all of which were for inoperative motor vehicles.

Planning Commission Activity: The Planning Commission met on January 28, 2015 and received a status report on the newest U.S. Route 460 Bypass project proposal and its effect upon the pending Comprehensive Plan. The Plan remains in limbo until a final decision is made. The Commission also reviewed a Staff presentation of the entrances to the Town and its major intersections. Potential policy options were reviewed as to how these situations could be improved.

Other: I will be in and out of the office over the next several weeks dealing with my wife's knee surgery. My home telephone and personal e-mail will be left in Town Hall so that I can be readily contacted.

Because a final decision by the Virginia Department of Transportation on the U.S. 460 project will not be complete, and the corrections to the Comprehensive Plan have not been completed and the dearth of new cases, the next Planning Commission's meeting scheduled for February 25, 2015 may be cancelled. A final decision will be made next week.
