SUBJECT: Trash Collection RFP Results

As you know, we recently put out a request for proposals for weekly trash collection. The proposals were due by May 29th.

We received two proposals. One from AVES, and one from Bay Disposal & Recycling. I have attached copies of both to this memo.

As you can see, AVES rate of \$5.97 per stop per month being substantially cheaper than Bay's rate of \$9.38 per stop per month.

There had been some discussion as the length of the contract that Council wanted to have for trash collection. Previous contracts have been for a period of five years with a five year renewal. I ask that Council determine what length of time it would like the contract to be for, and add that language to the recommended motion.

It is my recommendation that Council authorize the Town Manager to execute a contract with AVES for trash collection in the Town of Windsor.

I am writing in reference to your request for proposals for weekly curbside refuse collection. As per your specifications, the pricing is based on the following criteria:

- Bay Disposal & Recycling would provide one "NEW" (1) 95 gallon cart to each of the approximate 950-service locations
- The 95 gallon carts would be serviced weekly on a day mutually agreeable between the Town of Windsor and Bay Disposal & Recycling.
- Bay Disposal & Recycling would provide collection via automated collection vehicles.
- All trash collected would be delivered to the SPSA transfer station and the disposal would be invoiced to Isle of Wight County.
- The contract would be for a minimum of three (3) years with up to five (5) years in renewal options.
