Subject: Monthly Summary Report for July 2014

On 7/2/14 Officer Swan stopped a moped in the 25000 block of Buckhorn Dr. for a registration violation. Operator was later determined to be under the influence of alcohol and arrested without incident. Suspect was charged with Public Intoxication and multiple traffic violations.

On 7/8/14 Officer Harris responded to a disturbance call at the Windsor Court Apartments. While investigating the incident it was determined that one of the involved subjects was wanted on an outstanding misdemeanor warrant for Child Support out of Virginia Beach. Suspect was arrested without incident.

On 7/9/14 Officer Swan conducted a traffic stop for a speeding violation at Windsor Blvd. and Watson St. Upon approaching the vehicle he noticed a strong odor of marijuana. Officer Swan recovered 2 grams of marijuana along with additional drug paraphernalia. Passenger and the driver were charged with Possession of Marijuana. Contraband was seized.

On 7/10/14 Sgt. Jernigan was investigating the theft of controlled narcotics from Consulate Healthcare. During the investigation it was discovered that the husband of the suspect was wanted out of Hampton on a Misdemeanor Warrant for Child Support. When the husband arrived at the police station with the suspect he was arrested without incident.

On 7/11/14 1st Sgt. Riddle responded to the Exxon at 59 W. Windsor Blvd. for a report of credit card fraud. The manager and a customer advised that an employee had stolen the victim's credit card number and using the card at the store. Employee was confronted and admitted to stealing the credit card information and stealing from the store. Suspect was arrested and charged with Theft of a Credit Card, Embezzlement and Obtaining Money Under a False Pretense.

On 7/12/14 1st Sgt. Riddle was continuing the investigation into the previous credit card theft when additional criminal offenses were uncovered. The investigation determined that the suspect had used the stolen credit card number to make additional purchases and had stolen gift cards from his employer. Warrants were secured for Credit Card Fraud X 4 and another count of Embezzlement. Suspect was arrested without incident.

On 7/13/14 Officer Harris obtained a warrant for DUI as a result of an investigation into an ATV accident that occurred on 6/15/14 in the 25100 block of Buckhorn Dr. The suspect was arrested without incident in the City of Chesapeake.

On 7/14/14 Sgt. Jernigan responded to the 400 block of Hidden Acres Circle for an assault in progress. Upon arrival it was determined that the estranged wife entered the mutual residence and assaulted the husbands' girlfriend. Victim suffered multiple abrasions on her face. Suspect was arrested for simple assault and an Emergency Protective Order was obtained and served. Suspect obtained a counter warrant for simple assault on the victim and an Emergency Protective Order. Sgt. Jernigan arrested and served the victim without incident.

On 7/26/14 at 0215 hours Officer Harris stopped a vehicle at 60 W. Windsor Blvd. for speeding. Upon making contact with the driver Officer Harris noticed a strong odor of alcohol. As the result of a DUI investigation the suspect was arrested and charged for DUI with a BAC of .09. Suspect was transported to WTRJ without incident.

On 7/26/14 at 1657 hours 1st Sgt. Riddle stopped a vehicle in the 11300 block of Windsor Blvd. for speeding. Upon making contact with the driver and passengers of the vehicle 1st Sgt. Riddle observed drug paraphernalia in plain view. The Sheriff's Office narcotics K-9 responded to the scene and made an alert on the vehicle. During the search of the vehicle officers recovered 11 grams of marijuana from the glove box and 13 grams of marijuana from the trunk. Driver was cited for Speeding and Driving on a Revoked License. Two passengers were charged with Possession of Marijuana.

On 7/26/14 at 1925 hours 1st Sgt. Riddle and Officer Swan responded to a call in reference to a Psychiatric Problem in the 11000 block of Beale Dr. Upon arrival officers made contact with the victim's wife who advised her husband suffers from PTSD after serving in Afghanistan in the Army. The wife advised her husband was becoming violent and agitated and refused to get help. Victim was barricaded in the bathroom and armed himself with a towel rod. Officers were able to talk the victim out of the bathroom and take him into emergency custody without incident. Victim was transported to Western Tidewater Mental Health for an evaluation and admitted to Riverside Psychiatric for further treatment.

On 7/30/14 1st Sgt. Riddle responded to Town Hall in regards to a larceny of public utilities. Investigation determined that the suspect had stolen 44,650 gallons of water over a 6 month period valued at \$312.55. A warrant was obtained for Theft of a Public Utility. Officer Swan arrested the suspect without incident at his residence on Church St. later that night. Suspect also had an outstanding warrant for Contempt of Court.
