Ref: K-9 Program

The Windsor Police Department has obtained a dual purpose police canine from the Newport News Sheriff's Office and Sheriff Gabe Morgan via a very generous donation. The canine is certified in narcotics detection and patrol tracking & apprehension. In addition to the animal the NNSO also donated a kennel set up. The K-9 a 5 year old Dutch Shepard named "Odin" has a clean bill of health and has been assigned to Officer C.J. Griffin as his handler. Officer Griffin and his new partner Odin will begin the K-9 certification program later this month. We expect to have them fully operational by the end of April. Police K-9 programs are generally very expensive to start up with most programs costing in excess of \$40,000.00 to purchase and train the K-9 and handler and then outfitting them with the necessary equipment. With the donation of the K-9, kennel and Spikes K-9 Fund donating the body armor for Odin we will have invested less than \$7000.00 dollars into the startup of this program from the police budget. WPD is very excited to have this new officer and his K-9 capabilities at our disposal.
