Subject: May 2015 Planning and Zoning Report

Zoning Permits: The number of Zoning Permits increased to ten from the nine in April of this year. This is much higher than the four in May 2014. We have now equaled the total for FY2013-2014 permits (83). The permits ran the gamut of building activities. They included two new homes, two temporary signs, a permanent sign, three fences, two pools, a pool deck, and a home occupation for a mobile electrical repair business. One of the pool projects had to have a fence and also included the pool deck. Thus, the number discrepancy.

Violations: Spring always gives an increase in the number and diversity of violations. This year is no exception. The violations continued to grow to fifteen in May up from the thirteen in April. This is also decidedly larger than the ten in May of 2014. Eight of these cases were for inoperative motor vehicles, three were for tall grass, one was a sign violation, and the remaining "other" cases were for two debris cases and a sign violation. Seven violation cases were resolved. Three were for four inoperative motor vehicles, a tall grass case, a sign violation and aforementioned two debris cases.

Planning Commission Activity: The Planning Commission met and Girl Scout Troop 1105 gave a very informative presentation on their murals project and the positive effects it may have upon the Town. The Commission also agreed to hold a work-session in conjunction with their June meeting on the Olde Towne Windsor concept and any other elements of the proposed Comprehensive Plan that are not affected by the proposed U.S. Route 460 Bypass (Preferred Alternative). The 2015 Capital Improvements Plan was unanimously recommended for approval to Town Council by the Planning Commission.

Other: Staff also attended the VDOT public meeting on the aforementioned project and the Land Use Education Program in Charlottesville. With all of these activities, May was a very hectic but productive month.
