County School Board for Career and Technical Education (CTE) Building Trades

Program

Background

Town Council has negotiated a MOU with the Isle of Wight County School Board to materially assist the Career and Technical Education (CTE) Building Trades Program.

Specifics

The agreement allows the Town to assist the CTE Building Trades Program in the potential construction of a single-family home as hands-on experience for students in the program.

Primarily, the assistance is to convey by deed 0.38 acres +/- of land located at the intersection of N. Court Street and Joyner Town Road in the Town of Windsor and identified as Tax Parcel No. 54-01-019. This parcel was previously a well site for the Town water system, but the well has since been abandoned.

Further, this project has the potential to put vacant property to beneficial use as a new home site.

Memorandum of Understanding (MOU) between the Isle of Wight County School Board and Town of Windsor For

Career and Technical Education Residential Home Project in Windsor, Virginia

THIS Memorandum of Understanding ("MOU") entered this __ day of _____, 2023 by and between the Isle of Wight County School Board ("School Board") and the Town of Windsor ("Town") (collectively "Parties").

WHEREAS, the Town owns real property listed as Parcel # 54-01-019, located on N. Court Street in the Town of Windsor, Virginia; and

WHEREAS, the School Board provides practical training to students through its Career and Technical Education ("CTE") program; and

WHEREAS, the School Board seeks to deliver instruction through its CTE program by engaging in a residential construction project; and

WHEREAS, the Parties recognize that cooperation between the Town and the School Board will effectuate these goals:

NOW, THEREFORE THE PARTIES AGREE AS FOLLOWS:

- 1. The Town will transfer the property listed as Parcel # 54-01-019, N. Court Street, Windsor, Virginia ("Parcel") to the School Board via deed, for the purpose of its CTE program to construct a single-family residential dwelling ("Project") on the Parcel.
- 2. The Project will be managed by the School Board's CTE Building Trades department, with supervision from a Commonwealth of Virginia, Class A licensed contractor, and shall observe all local, state, and Federal laws.
- 3. The Project will, to the extent possible, emulate the size, character, and functionality of recently constructed single-family dwellings on adjacent, and comparative properties in the Town of Windsor and/or Isle of Wight County.
- 4. Upon completion of the Project, the School Board/CTE will list for sale the Parcel and Project at a fair market value, consistent with recent sales of adjacent and comparative properties in the Town of Windsor and/or Isle of Wight County.
- 5. After the successful completion of the Parcel and Project, and subsequent sale of the same, the School Board shall first use proceeds from the sale of the Parcel to remit to the Town the amount equivalent to the Parcel's 2023 tax assessed value, plus reimbursement for any and all permits, fees, or costs related to the Project which shall include but not be limited to the zoning permit fee, rezoning application fee, waiver application fee, and water tap fee; and thereafter, such further proceeds from the sale shall be retained by the School Board to facilitate future practical training of students through its CTE program.

- 6. Should the School Board and CTE program determine that the Parcel is not suitable for the Project, or are otherwise unable to complete the Project, within two years of transfer of the Parcel, then the School Board shall deed the Parcel back to the Town.
- 7. The Parties agree that none of the provisions of this MOU are intended to create nor shall be deemed or construed to create any relationship between the Parties other than that of independent entities contracting with each other solely for the purpose of affecting the provisions of this MOU. The Parties have no express or implied rights, nor authority to assume or create any obligation or responsibility on behalf of, or in the name, of the other party, except as may otherwise be set forth in this MOU.
- 8. The Parties acknowledge that neither this MOU nor the transactions contemplated hereunder constitute or shall result in a waiver of the School Board's or the Town's sovereign immunity.
- 9. This MOU shall be governed by the laws of the Commonwealth of Virginia.

IN WITNESS WHEREOF, the parties have caused this Memorandum of Understanding to be duly executed intending to be bound thereby. This Memorandum of Understanding becomes effective on the date of the last signature.
